I ended my last newsletter with three challenges that I felt humanity now faced. Positive people say that we must turn challenges into opportunities. This requires us to become much more positive.

What helps us become far more positive is when we experience much more Energy.

I believe we can do this in several ways but in this newsletter, I want to write about connecting to the land.

So the theme for this newsletter is about receiving this energy from the land and I was given a timely reminder of this myself last month in two ways. The first you will know I have written about before and that is the energy we can receive at special locations on the harmony times during group meditation. The second is from some particular types of landscape.

September Harmony time

The harmony time group meditation last month was uplifting in many ways.

I knew of at least 50 events going on around the World at their respective midday times. There were varying numbers from the 1's and 2's to the highest number of people I have ever seen at Oliver's Castle in Wiltshire.

That so many people are now doing this and experiencing how the energy is inspiring them is most heartening.

At Oliver's Castle, one person counted more than 150 of us gathered together. It was an absolutely beautiful, windless, sunny day which was made so much all the better by everyone who came along.

There seems to be some kind of joyous peacefulness to the people who gather on these occasions. Everyone gets on with each other so well and we have to bear in mind that, with so many people, there are almost certainly people there with different views.

I am reminded of the different tribes of Native American Indians that put aside their differences, even stopping to fight one another, to return to a communal gathering every four years.

It gives me great hope for the future.

This month I had high hopes of not subjecting you to another long missive this October but, as the month end drew closer, more information just came along that really needed to be spread as much as possible.

In the **Earth energy section**, I write about one of the most significant type 4 alignments (Leys/Leylines) found running through Europe and take a look at where it is heading on other continents. I know I wrote about another significant ley in Europe a few months ago (*The one that ran from Maeve's cairn in Sligo, Ireland, through Newgrange, Angelsey, Royston, Troyes etc*) but this one easy tops that in quite an incredible way.

I am actually of the opinion that no other type 4 alignment in the World passes through such a large number of amazing sites and, in re-finding it, I was blown away by further synchronicities.

I mentioned this same Ley in my last three social media posts and readers of these will remember the extreme level of synchronicity and personal feedback that I experienced when tracking this alignment. If I had not had this kind of feedback, I probably would not have believed what I found in regards to where it ran through and where it is headed.

In the **Science section**, because of the theme of this newsletter, I really had to tackle a subject that took up 15 years of my life and this is how intelligence and energy are so closely linked at the very smallest of possible scales.

In the **Books section**, I mention a book that I helped co-author over 10 years ago now. This is included as it supports the information written about in the Science section and it hopefully will go some way to explain just why we can feel so energised from ancient mountainous landscapes.

In the **Social media section**, I cover a short video that I have put up that helps understand something called Opposed Energy Dynamics. This is at the heart of the new Big Breed theory of Creation and how intelligence must have arisen to then be able to go on and create the different matter frequency worlds of Spirit and our matter frequency World.

Last, but not least, in the **Other section**, I am including three articles written by other people and I have added some comments to them.

I can report that permission has been finally given to the great Mr John Dee, to go ahead and publish his work on data supplied from a high level whistleblower from a UK NHS trust hospital. It is truly explosive stuff. I have added headlines and the summary of his report and a link to the full pdf but to give you a taster now here are some of the really big 'reveals'.

1. Only a staggering **0.08% of admissions** had a relevant respiratory diagnosis with a SARS-COV-2 diagnostic marker over the first six months of 2021.

Do take your time reading it, there is no rush. You will probably know much in here already but it has been put together very succinctly. This needs to be spread so it becomes common knowledge so everyone knows who and what we are up against.

For me we absolutely need to know the reality and turn any fears we have into positive expectations.

To help with this, I want to turn to the image at the start of this newsletter and the second way we can receive wonderful energy from the land.

Energy from the land

My wife and I managed to get away for a few days last month for the first time in a long while. We had been drawn to the land of my ancestors and the mountains in North West Scotland. Having spent a few days acclimatizing on the magical island of Skye, it was time to press on further Northwards and into ruggedness of the Torridons.

Here you are treated to sights that instantly soothe tired eyes like the remarkable Coire a' Cheud-chnoic – the valley of a hundred Hills.

The image above shows the North West end of Loch Maree from a point just North East of the small fishing village of Gairloch.

Here the weather can change hourly providing a multitude of different moods and scenic views of the same landscape. As we drove, it felt like we watching the beginning of a new movie every hour or two. From a Tolkein-like fantasy to a Drama & then to Mystery, we experienced it all.

However, it is not until you get out of the car though and walk the land do you begin to notice the difference.

The rocks here are not the same as ones you are used to elsewhere in the UK – even Europe – for these are some of the oldest rocks in the World and they tower above you either side.

Their continual presence just cannot be ignored. Close your eyes, or walk late at night and you can still feel its presence.

It leaves you in a constant state of awe whether you are on one of the white sandy beaches or running on a trail whilst surrounded by purple heather. The presence of this ancient rock is always there and it is always invigorating.

I shall try to explain by giving you some concept of the age of these rocks.

We are in the land of the Lewisian Gneiss which is over 1500 million years old. This is a metamorphic rock formed at depth within the Earth's crust under immense temperatures and pressures.

Back then this rock was uplifted to the surface it formed one of the earliest continents on Earth. Weathering and erosion by rivers eventually ground these mountains down to the size of hills and these in turn were ground down to the size of sand grains by these waters.

These sand grains were then, over many more millions of years, overlain by another 7.5 km thick sequence of sediments that were also laid down after the erosion of this very early land mass.

Over great eons of time, these sands became compacted into the extremely hard Torridon sandstone around 1000 million years ago. Anything this old is called Pre-Cambrian.

Much of this great thickness of Torridon rock we can see today was also eroded away and afterwards, this early continent gradually sank down deep enough until it was covered by a shallow sea.

It was in these seas that the first forms of complex life appeared around 541 million years ago. Creatures like Trilobites first made their appearance. This began the Cambrian age.

Most of the sediments that had collected at the bottom of these seas now went through further erosion and more tectonic movement leaving only small signs of its existence for us to see today.

One hundred million years later, the area began to feel the squeeze of huge pressure coming from the North West and the South East as two great tectonic plates began to collide against each other.

The Great Atlantic plate to the North West with its strong and dense Lewisian Gneiss was being forced against the weaker European land mass to the South East – one of them had to give.

439 million years ago this led to massive faulting of which the most well-known one is called the Moine thrust fault. This North East to South West directional fault is what defines much of what we see in the North West of Scotland today.

A thrust is a low angle fault where rocks are pushed great distances over other rocks. In this case the land to the South East had to give way as it was forced up and over the harder denser Gneiss to the North West causing the former to fold over on itself again and again for many kilometers.

The prominent cliffs overlooking the head of Loch Maree are just one of the results of this.

Huge amounts of energy, over extreme lengths of time, went into the making of this land. The result is extremely dense ancient rocks that loom large on all sides when you walk through the land.

The question that should rightfully now be on your mind is why would that make a difference to us? Why would we feel so much more energised by these rocks and from spending time in a landscape like this?

Yes, we can be drawn to the energy of a place and yes we can be drawn to ancestral locations, but there is more to the North West of Scotland and its rocks. The energy here is palpable to anyone who enters into a state of open awareness.

This is not just my homage to North West Scotland, though. There are many other parts of the Earth with Ancient rocks and where these are uplifted into mountains, the energy there too can be felt in this dramatic way.

In Geobiology we find energy centres where we find intersections of the linear high pressure concentrations of ultra-low frequency vibrations that emanate from our inner core, but this alone does not explain the constantly energised feeling you get up there.

One aspect that goes some way to explain this is the dramatic topography. With rock under your feet and like walls around your body, the energy is coming at you from nearly all angles.

It is an energy that intensifies your conscious thoughts, visualisations & feelings and that widens the difference you experience between your conscious and subconscious mind.

That might not seem important, but it is actually vital when it comes to energy receptiveness.

I never fully recognised this significance of this in my 20's when I worked 7000 feet underground in the gold mines but I remembered the effects to this day. There were times when I had to walk for an hour in near darkness, following the rail tracks to get to a developing end of the mine. It was also often incredibly silent. The rock all around me was quartzite and that too was highly faulted having been subjected to years of compression in what was structurally called a shear couple environment.

In the time that I walked, my visualisation and my thinking were more intense than anything I had ever experienced on the surface. At the time I wondered why that might be the case but it was not until 15 years later that I began to learn the reason why.

Back then I was researching whether gravity had anything to do with Chi or Ki energy and I wondered what the effects might be of trying to use human Ki energy in Space. That meant speaking with an Astronaut who might be willing to answer some questions. Trying to find an Astronaut turned out to not be at all easy at first until I put it out to the universe and tried to explore what came back. Within days one of the lady's in an office I had been working in starting mentioning to me that she had started writing a book. I enquired what the subject might be about. She replied that it was about her family. I enquired further and it turned out that her sister was married to an Astronaut and they lived in Florida.

I was very kindly given permission to make contact and of the several replies that I got back one stood out. Dreams were much more intense in Space.

It seemed now that our conscious mind had the capacity to be much more intense with its thinking, visualising and feeling when closer to the centre of the Earth and when surrounded by dense mass on all sides and that our subconscious mind was much more intense in its thinking, visualising and feeling when further away from the centre of the Earth and when not surrounded by any dense mass.

Dowsing had taught me of the importance of switching quickly between intense focus in one's conscious mind when asking questions and moving to intense awareness when waiting for a response from one subconscious mind so there had to be a connection.

The clue was in the amount of difference between the two intense states and between the two mental states of the conscious and subconscious mind.

The greater the difference you could create, the more the energy would seem to come through and into you when you switch from a focus to an aware state. It would seem that it is our mind's capacity to be able to do this that is important.

With dense ancient mountains on all sides, it was like being 7000ft underground and this was such a huge contrast that, when you switched into an aware state, energy would just rush into you.

When walking in this kind of scenery it can leave you in complete awe and it is here that we find the two extreme differences in intensity.

On the one hand you would have the intense focus of conscious thinking visualising and feeling brought on by the presence of the rocks on all sides of you, but then you would also have the awe of the place opening up the energy channels to the subconscious mind.

Just walking through nature like this and allowing yourself to switch into subconscious awe was like meditating ones way through nature in a way that brought huge downloads of energy.

The same would happen with forests and ancient woodland with dense woodland all around you actively helping you create this huge density and intensity contrast as you switch between mental states.

There is just no comparison when walking through a flat empty and relatively young landscape over soft and much less dense sedimentary rocks as it does not help you reach such intensity contrast. That does not mean it is impossible though. An experienced person who had developed the capacity

to self-generate this intensity contrast would still be able to bring energy into their body and the out again for reasons like healing others.

There is of course much more to this and in the science section, I want to explore one aspect in further detail and that is the very essence of where this energy originates from.

Earth Energies

Over the many years I have been dowsing earth energy lines, I have had the pleasure to meet some very lovely people who have been sensitive to these linear high pressure ultra-low vibrations to the extent that they have noticed they are drawn, and have been drawn in the past, to these places all around the country.

What initially surprised them was that these locations were all, also, connected by straight lines. These were not just places where they lived, but also where significant events occurred for them. Many of these people had investigated this phenomenon further only to find that these event/locations lines over their past were linked to a particular type of energy line.

Gary Biltcliffe & Caroline Hoare in their book *the Spine of Albion (June 2021 newsletter review)* also showed evidence that consciousness like this had been connected to the Belinus alignment over recent times. Indeed, it is connections like this that helps us see that these energies are not just ultra-low vibrations but that they are also connected to consciousness itself and most like the Universal consciousness.

The only scientific theory that explains this is Ron Pearson's Quantum Gravity theory which is why I am such a supporter of this theory. Intelligence behind the Universe, Survival after death are integral thinking if we are to progress as a species into our next phase of conscious evolution.

I am writing this at the start of this Earth energy section to establish that what I am about to write about is nothing new in regards to our own journey through life and our connection to these energy lines. We have moments in life that can have an element of intensity that we might not initially expect. This intensity though helps us remember these moments for reasons at the time, we may not actually be fully aware of.

I suspect now that these are times when the energy or spirit of the place speaks to us with a burst of intense energy.

One of these places did this for me at the age of 14. My grandmother lived nearly all her life in Fortrose on the Black isle – just North of Inverness in Scotland. I was fortunate to spend many summer months up there.

One summer though my Grandmother took my cousin and I further North right up to the Orkney islands. Of the many delightfully interesting sights up there we visited one stood out for me – Scara Brae.



Back in 1850 a great storm hit the islands and the high tides ripped the top of the grass on the beach on the West side of the main island. What was uncovered were eight Neolithic dwellings all linked together by a series of low passage ways. Each dwelling had a large square room with thick walls, a central fireplace and a bed either side of a stone shelved dresser that was set against the wall opposite the doorway.

When we visited this place nearly 50 years ago now, we were on our own. There were no tourists, no ticket offices, no signs and no roped off areas. We ran all over the place pretending to be early inhabitants running down the passageways from one dwelling to another. The wind whipped around our heads as the waves crashed onto the beach. It was a magical time.

Since then, I learnt that this site was used between 5200 years ago to around 4200 years ago. These 8 Neolithic homes were just 7km to the North West of another ancient site called the Ring of Brodgar (4600+ years old), the Ness of Brodgar (5300years) which is found on a narrow spit of land between the Ring of Brodgar and the Stones of Stenness (5400years). The ages are rough estimates and all of these sites were probably in use at the same time and probably for many generations. As a gauge to other ancient sites, it was in use around the same time as the Avebury stone circle which, incidentally, has a similar energetic configuration with a node that moves over the seasons.

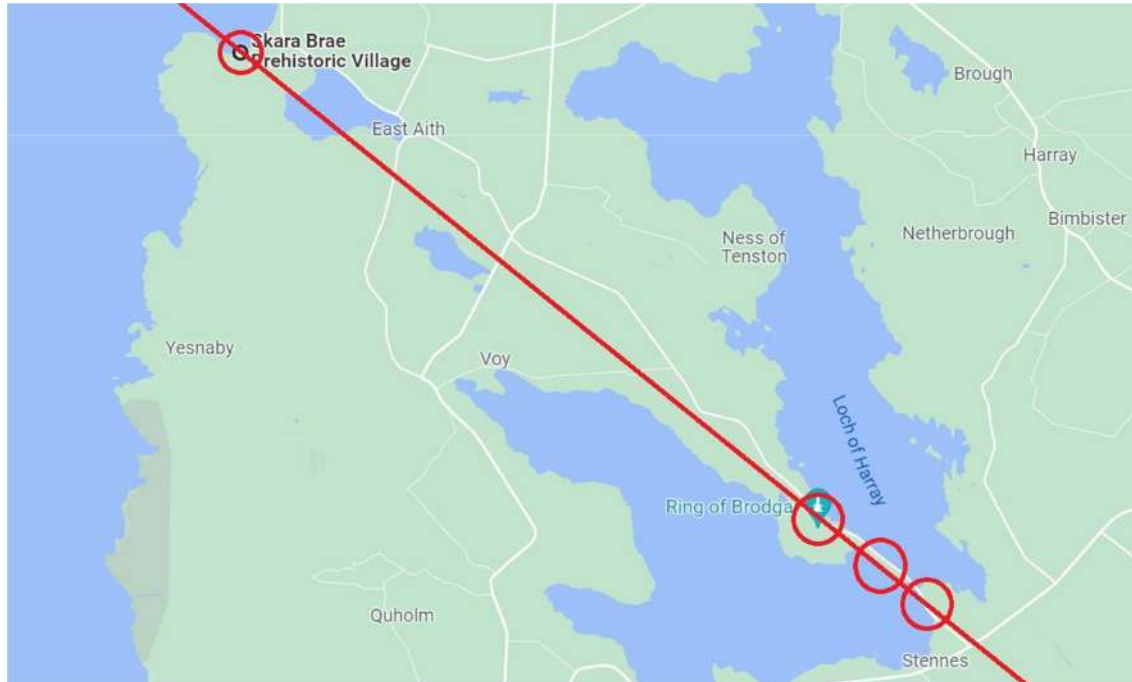

The round circular henge is just visible but several of the original stones in the circle are now missing.

In summary, there were once two large stone circles either side of the Ness of Brodgar. The latter has been investigated by Archaeologists who describe one building there as 'Temple-like.' The fact that it has 4 metre thick walls and is 25 metres long and 20 meters wide with a standing stone with a hole shaped like an hourglass incorporated into the walls, with a cross shaped inner sanctum inside it all and a paved outer passage, strikes me that 'Temple-like' is a huge understatement.

But then these Archaeologists could not possibly accept that it sits on a type 4 alignment with a pair of type 4 Earth energy lines running through all these sites.



There is of course the huge question of why we find two stone circles either side of a large temple area on a narrow spit of land where there is a temple. Only when you include discussions about all the energy lines in this area, and not just the pair of type 4 earth energies, can you begin to understand what was going on. Mainstream archaeologists are unfortunately not allowed to transgress beyond the boundaries of their own discipline.

What is not shown on this image is the other type 4 alignment that heads through this complex from the South West and up to the North East.

At age 14 of course, I did not know any of this. It only came to my attention around 15 years ago when I was mapping the type 4 alignments around the UK. Even back then though, I had a slight drawback which meant accuracy was not easy to establish. The Orkneys are not wide islands and the direction of this line was not at all easy to establish over longer distances and across great expanses of the North Sea. So there was little chance then of knowing exactly where it might have entered Europe, nor where it went out into the North Atlantic.

That all changed though earlier this year along with a massive update last month.

In 2020, I had some time to progress my mapping of the European type 4 and type 5 (Emperor Dragons). With some kind people requesting sacred site searches in Holland and Denmark, I had tracked the type 5 lines into Sweden and had found most of the type 4 alignments that had crossed those lines.

Timing and following synchronicity is something I heavily rely upon in this work as it provides the necessary additional feedback that you are on the right track. I have written before about this along with unexpected discoveries when you zoom into the small scale.

It was the latter that hit me twice back in April this year when a lady requested a sacred site search in Iceland. It turned out to be one of my toughest ones yet as the aim of the search is to not only find a nearby sacred site but to also see how it ties into the network of the Emperor Dragon lines.

My initial work looking for type 4 alignments that crossed Iceland brought the first problem. There were only two of them and one of just crossed a remote, isolated and uninhabited part of the country. The other one ran through a tiny fraction of land on the South Western tip of the island. It was just enough to establish a direction but little chance of any sacred sites on the short stretch of land that line that crossed over. It was mostly a wilderness with a few coastal fishing villages and towns. I decided to leave finding a sacred site till last and went in search of a connection to the Emperors.

As good fortune would have it, I found that this alignment was the same as the one that ran through Skara Brae and the Ness of Brodgar complex. I also found it entering Europe and heading down into Germany. What helped here was that my previous mapping of the coastline for other type 4 energy lines had eliminated many of the possible areas the line from the Orkneys could have come ashore.

There was also an alignment that I knew of that headed roughly West from the 2nd order node at Koln Cathedral.

What followed was tracking these two type 4 alignments as they got closer to crossing each other. I had no idea where that would be as I headed Eastwards.

When I do my remote mapping I start first on a large scale and then work down to smaller scales. It takes time but it is more accurate. The node eventually appeared in a small wood to the East of Hanover. It had to be precisely found in case it needed to be repaired so I went down the scales further until I could see the tracks in the wood and the outline of a small lake.

The node was found and all I had left to do was to give it a name. I noticed the name of the wood was 'Im Himmelreich'. Not speaking German, I put that in an online translator to find it meant 'Kingdom of Heaven'. I felt that was pretty neat feedback so I named it the Kingdom of Heaven node.

The alignment had begun to take on some significance so I decided to track the Iceland Ley down to the South East a bit further. It was not long before I found the site mentioned in my last social media post.

A quick search online to learn more about this place and I found an article giving it the name Germany's Stonehenge. Having studied it in a bit more detail it looked more similar to the Stanton Drew circle South of Bristol UK with its timber circles. This was the Goseck Sun Temple and one that dated back 7000 years – very awesome.

Its two main entrances exactly aligned with the sunrise and sunset on the Winter Solstice and two smaller entrances that aligned with the Summer Solstice. This was definitely used for meditation and prayer at these times.

I had no time to follow the line further to the South East at the time as I had to return to finding a sacred site in Iceland. A small island of the coast offered promise with an ancient chapel but that was more than an hour away from the target area. The only thing to do was to go deep down into

the small scale maps and see what might be found. This is where the search really starts and why I call it a sacred site search.

This is where the second massive feedback popped up. I was practically down to the street level maps going through the town that was right next to the alignment when up popped the words Viking Temple. Right between the warehouses and retail outlets at the side of the road, I could hardly believe my eyes. There was a circular walled building with a stone archway on one side and a mound with a cairn to the side. Next to that was a small stone circle. A quick online search and I could find nothing about the site at all. It had gone completely unmentioned.

I cannot help but think that this could be an excellent visitor attraction – especially on the days when it would perhaps be too cold to even swim in the hot waters of the nearby Blue lagoon.

That search was completed back in April this year and had it not been for another fellow Geologist and dowser making contact with me (Thanks Gary), I might not have picked up the thread again of this major alignment that crossed Europe until next year.

Everything happens for a reason though and synchronicity was about to raise its head again as well as another knock at the door from being personally familiar with this line. I had unconsciously played in its energies in Skara Brae but I was about to discover something far more recent and mindboggling.

Gary lived in the Czech Republic and asked if I knew of any main lines running through the country. Since he had a strong mapping skill from his geological background, I thought he might like to help map the type 4 alignments in that country. I knew of two alignments heading towards the middle of the country and one was the one running down from the Sonnenobservatorium – the Sun Temple at Goseck.

This now prompted me to look further along both ends of the line. Much about increasing the amount of synchronicity you have in life is about exploring what is going on and I had a hunch there was more to this Ley than I had previously thought.

A quick projection to the South East left me shaking. I really did not have time to explore the line accurately but if the projection held it was going to pass through two incredibly powerful sites.

The first one was a site that I knew was a 4th order node. I had looked at it many years ago and found the two type 4 alignments but had not tracked them far. The most interesting of the two leys at the time was the one that headed up to a similar 4th order node at the Temple mount in Jerusalem. This

Ley connected Temple mount with the Pyramids at Giza and it was the Pyramids that now seemed to be where the Goseck Ley was heading for.

More work is needed to establish this though and unfortunately there is no time for that right now as well as no synchronicity indicating I should do this.

However that same alignment now seemed to head down towards Eritrea in North East Africa to another tremendously significant site as this was a location where there was a node with one of the Emperor dragons there. Again, there is no time to validate this at the moment, but this is one of the countries most sacred sites.

Around 650 years ago, the locals had known about this sacred place for many centuries. It was however almost impossible to get there as it required a 2500 foot ascent from the nearby town. Back then, they decided to build a monastery at the top of the mountain so they could be constantly near to this highly energetic place. The monks are said to say that this place is the key to longevity. If you would like to know more search for the Debre Bizen monastery and yes it is on one of the Emperor Dragons – the Northern pair of the one that runs through the Lalibela site mentioned in one of my May 2021 newsletter. This type 4 alignment really does look as it runs through the Pyramids and connect with the Type 5 grid at this monastery.

What next drew my attention though was where the same Ley headed North West from Iceland.

An initial glance showed that the Ley was heading right across the North Atlantic Ocean and down through Canada into the USA – a place where I have spent nearly 20 months mapping these type 4 alignments. It therefore pretty much had to connect up with an alignment I had already mapped but not perhaps fully.

Two things instantly stood out. Firstly the Ley was heading right into an area where I had recently received a request for a full Geobiological survey for a large area of land in Southern Montana.

I had tentatively begun to look around about the area to establish where the main type 4 lines could be found. I had found three pairs of type 4 earth energy lines crossing over in a triangular shape with the Pryor mountains right in the middle of the triangle. This was sacred ground for the Crow nation and the land was known to contain several sacred locations.

That actually made me hesitate not wanting to draw any attention to perhaps any secret sites. I put off doing the survey whilst I did some further immersion into the land. Immersion into the land is easy to do physically but that was not an option so I set out to watch some online videos of the area. Travelling along the roads on street view also helps here.

Having watched several obscure videos, I let the information settle to see what might happen. It was not long before the synchronous Czech Republic connection was made & I now had a 4th type line heading for the area.

You might well ask why I had not found this 4th line before. Well the answer was that it was finally found a short distance to the West of the Pryor mountains and I had not yet expanded the search

that far away. *(In hindsight, there seems to have been good reason for the nudge I was given by Gary in the Czech republic, it was not just about missing that alignment in Montana, it was a 'heads up' as it was supposed to be part of the energetic complex at the Pryors as it had at some time in the past. It was all about the need to move it back to where it used to be. It seems that the universe will always find a way to get your attention when it wants to.)*

This now meant more nodes, more large vortexes and more possible connections from these into the target area for the geobiological survey and an even more energetic environment.

The synchronicity at finding the Goseck/Iceland Ley running to an area I was about to do some work in was fine feedback enough but I'd also discovered an even bigger one.

With the direction and heading this alignment was on, it could only exit the USA down in the Southern part of California. This was where my wife and I had been invited to back in February 2021 to run a week long dowsing training course. There was only one alignment down there that I knew of that had the right direction and I had run one of my training days on those same energy lines on the beach near the delightful town of Encinitas, near Carlsbad. *(Encinitas has a lovely combination of surfing and yoga enthusiasts. The former come for the great waves at Swami's beach and the latter come because that Swami was Paramahansa Yogananda who used to live there in the 1920's and 30's)*

From having stood on this same alignment when I was 14 years old, I had returned to stand on it again when I was 62.

I began this section by mentioning how events and locations in our life are connected to these energy lines and I was now in the middle of experiencing just that.

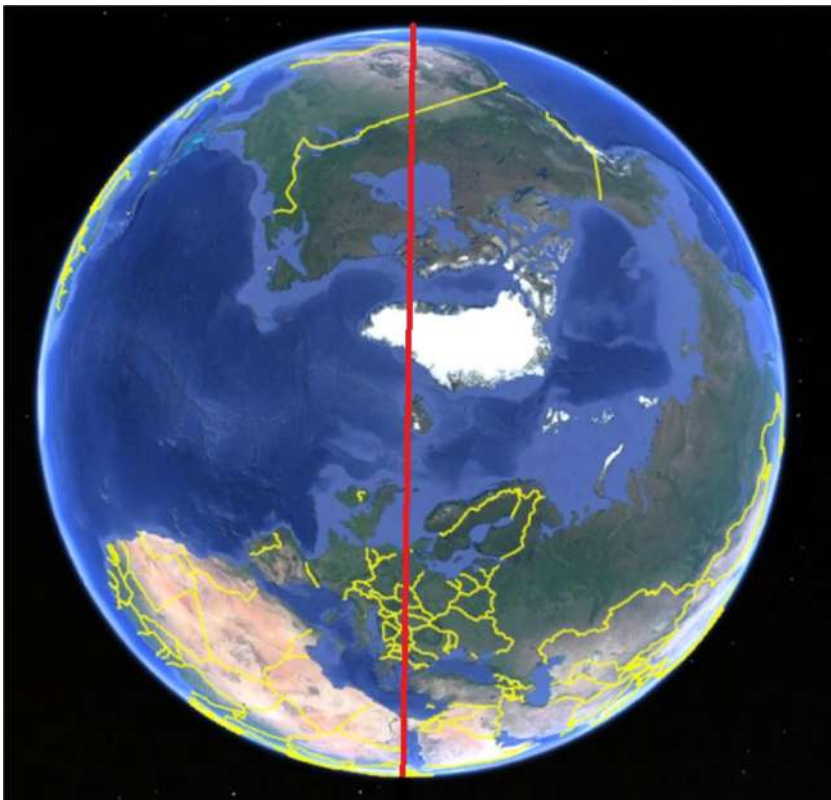
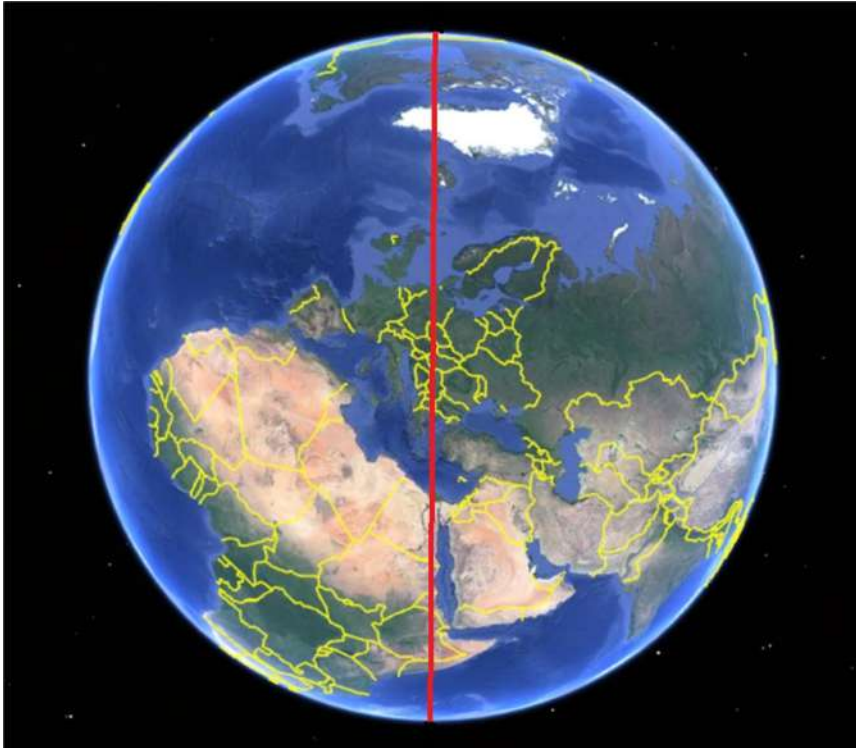
The two images below show this type 4 alignment as it goes around the land regions of the World. This is just one alignment. Consider now all the alignments with all types of energy lines all encircling our World in many different directions. It was not be that unlike a ball of glowing string.

Now consider all that string light vibrating at exactly the same frequency. Every single piece of land beneath our feet would be buzzing.

The vibrations in the water in the oceans and the seas would amplify this effect even further.

Just imagine now the effect of this on our own collective field of energy – our vibrational field, our electromagnetic field and our gravitational field – if we could resonate with this same universal frequency.

I think we are awakening to the effects of this right now. We are being helped to re-find ourselves as beings that exist within the magic of the Universe.



The above two world images show this type 4 alignment (Ley/Leyline) running through the countries mentioned above.

Science

Around 15 years ago, I found myself giving a lecture to a packed room of people at the College of Psychic studies in Kensington in London. The subject was on the Science that explains Intelligence behind the Universe.

I started by showing the assembled group of people a lump of Kimberlite rock. Kimberlite is formed by very deep seated volcanic magma of a very specific composition, rapidly coming up to the surface in a small pipe. They are often diamondiferous. Unfortunately my specimen contained no diamonds.

I started by telling the audience that it did contain something else – intelligence.

It was because I had studied Geology round the corner at London University that, even though I had learnt what I was about to talk about, I found it slightly strange as a geologist to begin a talk by stating that intelligence could be found within a rock.

Although it was at that time a recently unexpected viewpoint, it was one that was fully supported by a new scientific theory on the creation of the Universe. When it comes to the theme of this newsletter, this will also now help to explain how why we feel so energised by the magic of ancient mountains landscapes and how it can help us be and stay so positive.

This magical landscape can be broadened out to describe everything within the Universe. What would seem like magic to us though, would of course, be considered quite natural to a universal intelligence.

If a universal intelligence created all things, and is still in a process of continually doing so, it would perhaps be quite natural for us to experience this, and feel this in some circumstances, more so than in others.

The connection here that must now be looked into is between energy and intelligence.

Unfortunately, the idea of Universal intelligence has been an anathema to mainstream scientists for the last 100 years and they have fought tooth and nail, unsuccessfully, to suppress this for a variety of reasons.

With this subject always close to my heart, my attention last month was drawn to a scientific paper that was submitted on the 10th September 2021 for publication under the section 'History and Philosophy of Physics'

It was titled:-

"Life, the universe and the hidden meaning of everything" and was written by Zhi-Wei Wang & Samuel L Braunstein (*The full pdf of the short paper is here <https://arxiv.org/pdf/2109.10241.pdf?>*)

It was of interest because it was looking at the observations that have been made in the Universe that pointed to what has been called Intelligent Design. In other words – God.

In their abstract they question whether we see signs in the universe of intelligent design. They set out to look at whether a completely random universe could indicate no intelligent design. What they end up seemingly saying is that there are fundamental constants found in the Universe that appear to be fine-tuned enough such that life can emerge and be maintained.

Here are some of their comments

“A remarkable set of coincidences is required among the fundamental constants so that one resonant energy level exists, yet another level just fails to be resonant.”

“The cosmological constant must be between 120-124 orders-of-magnitude smaller than its naive quantum field-theoretic value”

“..were our universe random it would almost certainly have a low probability for life as we know it”

However, our current model of the universe hardly explains everything. There remain numerous long-standing open questions, many cosmological in nature, such as matter-antimatter asymmetry, dark matter, dark energy and more

As you can read, they admit that the current model of the universe fails to explain everything. If you read the full pdf you can also see them struggling with the problem of requiring multiple universes – something totally unnecessary if we choose to not need relativity theory.

Their arguments also go round in circles trying to explain the numbers of, non-random, fundamental constants found in the Universe.

The authors though are in good company when it comes to admitting the physicists are unable to make sense of it all with their models.

The problems in mainstream physics that are deliberately ignored by the media

In 1980, Dr. Alan Guth proposed the theory of inflation. Space had to expand and, since it had a high energy density, a huge input of energy had to be continually supplied. The problem was that this had to be supplied from the void of nothing.

The logic led directly to a major false prediction of the expansion of the universe.

In Guth’s mind, the inflation had to last for only a minute fraction of a second and then it had to be switched off. The trouble was – **Guth’s theory had provided no effective means for doing this.**

His theory predicted an ongoing inflation of huge magnitude and it predicted a rate of expansion, which according to the string theorist, Brian Greene, was **10 to the power of 120 times greater than astronomers can possibly allow.**

This simply quite ridiculously large number that can be best appreciated by comparison with the total number of atoms of the entire observable universe which could not be more than 10 to the power of 80.

This 'switch-off' problem came to be known as the '**Problem of the Cosmological Constant**'. (*The same constant that the authors of the above paper also refer to in their comments above*).

The thinking back then with this model was that this expansion was slowing down and eventually it would stop and everything would then start coming back into one big crunch.

That thinking though was soon proved wrong when the astronomer, Betram Schwarzschild, published observations of remote exploding stars called 'supernovae'. He showed that the expansion of the universe had to be speeding up, not slowing at all as theorists had predicted. (<https://physicstoday.scitation.org/doi/10.1063/1.882267>)

In order to patch up the inflationary big bang theory and to try and make it fit the new facts the concept of '**Dark Energy**' was invented. This is imagined as some mysterious substance pervading all of space and having the strange property of lying dormant for billions of years.

At some curious point in time, its latent power was somehow switched on to overcome gravitational attraction at great distances of separation, so causing all the galaxies to start accelerating away from one another.

Unfortunately, billions of pounds of wasted tax payer money later, **they have still failed to find any dark energy or dark matter.**

And there were still more deep rooted problems that some of them even admitted.

In 2005 at the 23rd Solvay conference in Physics Nobel Laureate, David Gross said "***We are missing perhaps something as profound as we were back then.***" (Back then was referring to the time before relativity was invented.)

David Gross continued in his speech to add the following:-

*"Physics greatest endeavour has ground to a halt. **We are in a period of utter confusion.**"*

*"**General relativity is incompatible with quantum theory.** Since the 1960's theorists have struggled to solve this problem, so far to no avail. And the trouble is **we have nothing to put in relativity's place.**"*

*"**String Theory cannot explain the accelerating expansion of the universe or tell us where space and time come from.**"*

The 'Theorists' never did solve these major problems. They now say the energies needed to allow space to expand are supplied via 'wormholes in space-time' from some higher dimension.

This seems to be an admission of defeat and implies they now accept that the required energy to form the universe has always existed without a beginning.

Fortunately, we now do now have a complete theory that can send relativity into its own illusory giant dustbin – the mythological black hole.

This is a far better theory and one that explains how intelligent design must have arisen in order to go on and create the many different matter frequency Worlds.

THE BIG BREED THEORY of the Creation of the Universe – by Ron Pearson

This theory explains how energy could have emerged from an unstable void in two forms. These forms called primaries exist at an extremely small ‘sub quantum’ level, where in the beginning, there is no larger ‘quantum’ level or the larger ‘classical’ level in which we live.

These primaries collide in ways that lead to both annihilation and creation but with a net additional creational effect. This provides the explanation for the expansion we find in the Universe.

What Ron Pearson then realised was that these primaries would naturally become interacting waves of energy. With the principles in place for showing how order can arise out of chaos, early computational like sub routines are shown to emerge in ways that could direct these waves to form particles of matter, where and when intended, on the larger quantum level.

Ron calls this sub quantum environment the **I-ther**.

It stands for **Intelligent Ether**.

This, and much more, can all be read, in an easy to understand way in the book that Ron and I co-authored. I write about this in the books section of this newsletter.

We took time to get his theory checked by several well know physicists and several papers he wrote passed peer review in a few scientific journals.

Here are details of two such people and what they said and wrote:-

The Nobel Laureate Brian Josephson of Cambridge University made a considerable effort to discourage the author by trying to fault the logic. His final response before giving up was, “I can see what you mean but I think you are wrong”. Since he did not say, “I know you are wrong”, and support the statement by any logic, we consider he has helped to provide us with credibility.

Professor J.P. Vigiier - Gravitational consultant for the journal ‘Physics Letters A’

“Your letter now seems to be correct as far as our referee’s and myself can see.....I feel indeed that supporters of the big bang theory (of which I am not) should discuss the energy problem at creation time (if there is one) and your contribution should not be ignored.

Here are some further words about the new theory:-

Ron Pearson’s ‘The Big Breed theory’ only explains creation of the i-ther, which is **the origin of the energies needed for building the universe of matter**. The i-ther had to self-organise out of chaos before it could go on to create matter in the next level of reality - the quantum world of mathematically organised energy.

Creation of matter could arise in a manner similar to that already described by the big bang theory but with a difference.

The four forces of nature and sub-atomic particles would now be programmed in a manner somewhat similar to the way we create virtual realities on computer screens, though now the i-ther itself would provide a three dimensional screen.

Also what we call ‘matter’ would be produced like self-replicating sub-routines. Replication would be arranged to cut off after a specified number of generations.

In this way an inflationary big bang would arise, this time with a switch-off means. The weird and unreal nature of the quantum level is also provided with an explanation.

For those of you with some scientific background, here are some of the new concepts and definitions that should be born in mind when considering this theory.

Opposed energy dynamics

This depends on two mirror images of mechanics involving positive and negative energies. *(The terms Positive and negative here are being used here with **no connection to electrical charge** which does not exist at this ultimate level and not even at the larger quantum level yet as that level has not yet been created by the I-ther)*

Primaries are the ultimate smallest objects in the Universe from which all else derive. They exist in two opposite and complementary forms in balanced amounts. One kind is made from positive energy whilst the other is of negative energy. *(Again nothing to do with electrical charge)*

We show that by collision of primaries made of opposite energies, both breeding and mutual annihilation occurs, to leave a net creation.

The result is to solve the major problem that invalidates the big bang. The solution also predicts the accelerating expansion of the universe and so de-mystifies ‘Dark Energy’.

The i-ther not Aether or Ether is a sub-quantum background medium extending to the very edge of the universe and built entirely of primaries. Only the transient forces caused by collision exist here.

None of the four recognised 'forces of nature': gravity, electromagnetism or the strong and weak nuclear forces exist at this ultimate level of reality. They emerge with matter at the quantum level being organised by i-ther, which we show has all the ingredients needed for the self-organisation by energy-fed chaos.

Consequently these four forces are regarded as abstract, being mathematically contrived. Matter becomes a semi-virtual reality being made from the real energies of i-ther but organised by waves generated from the i-ther. *(Matter is the Maya)*

Consequently the curious feature of quantum theory known as 'wave-particle duality' is incorporated. *(This is explained in a way that now does not need to resort to the absurdity of multiple universes.)*

Charge. It is important not to confuse positive and negative energies with positive and negative electric charge. Electromagnetism does not exist at the ultimate level of reality that is the domain of the two energies of interest.

ECM - **Exact Classical Mechanics** – Newtonian mechanics had to be revised to make it exact and extend it to cover speeds up to that of light and to extreme gravitational fields. This was a prerequisite for the opposed energy dynamics that had to apply at both i-ther and the level accessible to our senses.

Also because ECM started from quantum compatible assumptions and matched all Einstein's relativity achievements, this also provided a solution to the long sought theory of quantum gravity.

Potential energy is a concept that could not be incorporated and had to be replaced by an interchange of the kinetic energy of an object with energy of i-ther. The idea of negative gravitational potential energy should not be confused with the mirror image kind of negative energy on which the Big Breed theory depends.

In ECM theory all objects including the photons that are the carriers of light are made from 'sum energy'.

Sum Energy = Rest energy + Kinetic energy.

Rest energy is the energy an object is made from when standing still in local space produced by the i-ther. When an object is moving, then to the rest energy is added the energy due to motion called 'kinetic energy'. Primaries made of negative rest energy can be shown to have negative kinetic energy.

Photons are the carriers of light. They have no rest mass but have kinetic mass and so exist entirely of kinetic energy.

The speed of light is shown to increase with altitude or distance from a star. This arises as a consequence of ECM theory being based on Euclidean geometry and universal time.

Light also propagates through the i-ther: not relative to observers as in relativity theory.

New Red shift interpretation. Because light is locked to the i-ther, and the latter is expanding, photons have to move against the speed of recession. This means they have to speed up as they approach the observer and a huge extra 'red-shift' is involved that cannot be accounted for using any relativity theory.

Pressure gradients are induced by the net creation of i-ther to produce an accelerating expansion. In consequence energy density gradients also occur in the i-ther.

Black holes are also predicted by ECM theory but differ in detail from Einstein's theory.

Other existing concepts that have also **not been needed** in this new theory are as follows:-

M-Brane theory seeks to explain creation of the universe by pre-existing pairs of membranes in the 11th dimension crashing into each other. **It is not needed.**

String theory associated with the above is not required, nor are its extra dimensions

No Multiverse is needed since the Big Breed theory only demands a single universe.

No space-time is involved since ECM does not regard time and space to affect each other.

No Relativity required: ECM has light propagating through space.

The big bang theory is now optional but the Big Breed theory can supply the energy it needs and the creation switch-off means it presently lacks.

It is now extremely important to say that a theory can only be judged against its own initial assumptions.

In other words the initial assumptions for relativity theory cannot be used to judge the Big Breed theory – especially when this theory does not need to use relativity theory.

A person may argue about all the observations that relativity seems to explain here, but all these observations are also explained by the Big Breed theory.

***Relativity is just not needed** – And if you have read my earlier newsletters, it is my opinion that it was deliberately promoted in order to stop anyone else investigating the potential of any background*

medium as a way to tap into its limitless energy. This would have immediately marginalised the growing oil and gas industry and the huge power, wealth and control it gave to a few people – Rory Duff.

So you can perhaps now see why & how Ron Pearson's theory is so much better than the current theories that mainstream scientists have put forward.

He has unfortunately upset the two large communities.

Firstly his initial background was engineering not physics. He was the inventor of the gas wave turbine. He was a lecturer at the University of Bath for many years before he switched to studying physics and cosmology.

His background in Wave mechanics made him ideally suited to finding a theory that fits all observations in the Universe. His background in Engineering upset the physics community that did not want to think that an Engineer could solve what they considered to be in the realm of Physics and therefore something that could only be solved by one of their own.

Unfortunately, it also explained something else that upset another large community – the religious establishments around the World. This second upset was the fact that his theory also explained how intelligence must have arisen in order to go on and create the universe. He called this the I-ther. That he had explained this though was not the real problem, it was what it went on to do and that is to show how the mind survived after physical death of the body – almost immediately. This was an absolute threat to the churches who stated that the only way to salvation was through them along with much payment of your wealth.

However, if we now return to the recent 'History and Philosophy of Physics' paper that shows intelligent design must be at work within the Universe because of all the fundamental constants, we can perhaps see just how Ron Pearson really has been of great help to mankind's understanding of the Universe.

If I return now to the lump of Kimberlite rock at the start of the talk I did at the college of Psychic studies in London, you can perhaps now understand how the particles at the quantum level within the different crystals are all being generated at a smaller sub quantum level of the I-ther.

The i-ther, the universal intelligence, is continually creating the illusion of matter on the quantum level.

It is directing its waves to interact with each other to create spikes of energy, just like interacting waves of water. These spikes of energy pop up and then down and then pop up again as the waves and troughs between them cross.

The result is that you get the appearance and then disappearance and then appearance of a particle like a photon over very short spaces of time and precisely in the position that the universal intelligence wants it to be as directed by its computational subroutines.

(By the way this is exactly how Seth, in the book Seth Speaks by Jane Roberts, describes the true nature of reality. It phases into and out of existence.)

The rock I held was holding was therefore really just a bundle of energy that was being continually created by the underlying universal consciousness.

Now think back to the start of this newsletter to the ancient, 1500 million year old Pre Cambrian Lewisian Gneiss rocks in North West Scotland – some of the Universal Intelligence's earliest work on Earth.

With this hard dense ancient rock, surrounding you on all sides in an up close and personal way, a rock filled with energy from the universal consciousness, you can perhaps now understand why and how the intensity of this energy can be felt so much more easily in these environments.

You can perhaps see now that it is not just about the locations of the energy lines and the nodes. These linear features are just the high pressure areas that exist within a whole field of energy and there are several different fields based on the different frequencies of these lines.

All matter continually receives this vibrational energy from the inner core **and** it receives energy from the sub quantum level and the intelligent universal consciousness.

In essence, when you look at it in its entirety, it is all from this one source.

Consider now, this whole grand design game that is now being played out. This is based on a natural cycle of changes to consciousness itself. Individual consciousness to group consciousness and back again – over and over again as our solar system travels around our spiral milky way galaxy.

All these different fields of energy with their different frequencies become just one frequency – one unified field of energy – when our solar system is in the part of the cycle when it enters the galactic current sheet. These mark the times when we return to group consciousness. *(Which also appear to be the times which are so threatening to the ruling classes on our planet that they are no so desperate for us to not experience.)*

This is where and when we find our weaknesses being challenged and this gives us a chance to learn and develop and grow so we can turn these parts of our character into strengths.

This in turn better prepares us for what is ahead.

Below is a quick link to a short 1 min animation video that shows the breeding effect within Ron Pearson's Big Breed theory of the creation of the Universe.

Sometimes seeing something can be an aid to learning.

Essentially what you will see are two primaries – one turquoise one pink that have escaped from the void. *(They are not particles of matter)*

They are different in one way. As they separate from the void, one emerges with positive momentum; the other emerges with negative momentum - The latter means that its momentum is in the exact reverse direction as its direction of travel.

When two billiard balls hit each other, they exchange momentum. If one billiard ball had negative momentum though, and behaved like opposite collisions of primaries, the two balls would both move off to the same side. To conform to the rules of conservation of energy, this means that they would both have to increase in size.

When a small primary then directly hits a larger one, it causes it to split into two. This is known as the breeding effect and is the basis for explaining increasing expansion.

It is the nature of these collisions and annihilations that lead to a net increase in primaries and, from that point on, you get both generation of primaries from the void and annihilation back into the void. This is a mechanism that is now behaving like a fuel cell as it simulates the generation of constant power.

In chaos theory, when you have a constant source of power, order results.

Ron suggests that is what went on to create an ordered network of solid filaments that had waves of energy running through them.

Release of NHS UK Study Results

After discussions with various healthcare and medico-legal professionals I am delighted to announce that I shall be releasing a selection of analyses undertaken since June.

The volume of work stands at 12 reports, 68,559 words, 119 figures and 96 tables and is based on (anonymous) electronic patient records of 101,661 deceased persons and 897,842 emergency department admissions records.

It tells a story of poor coding of emergency department admissions and in-hospital deaths driven by zealous use of tests that are primarily useful as a means of supporting clinical diagnoses; instead they seem to have replaced sound clinical judgement.

Some may find it odd to start with report 11 in the series but coding of cases really is the heart of the matter.

If CIVOD cases had been coded and analysed diligently from the outset we wouldn't necessarily have experienced lockdown, NHS bed loss, loss of healthcare services, economic damage, erosion of rights and all the rest; instead, our healthcare systems would have quietly and professionally dealt with the situation.

I wrote report 11 because things were simply not adding up.

In a nutshell CIVOD wasn't acting like the terribly deadly plague it has been billed to be, and all features I was expecting like a surge in respiratory failure, hypoxia and disseminated intravascular coagulation simply weren't showing up in analysis.

Certainly there have been plenty of cases that were rather challenging for ICU staff but the clinical population, as a whole, when viewed through a statistical lens didn't reflect this.

After 10 reports and a fair bit of mumbling **I decided to take a good look at the clinical coding and wasn't exactly happy with what I found.**

Evidence-based medicine must start with sound evidence!

*An audit of 161,494 electronic patient records for admissions from 01-01-2021 to 13-06-2021 at a major NHS trust hospital, **revealed only 125 admissions (0.08%) with a relevant respiratory diagnosis and a SARS-COV-2 diagnostic marker.***

90.3% of all admissions** tagged with the emergency department identifier 'Disease caused by 2019 novel coronavirus' **were devoid of supporting diagnoses

The Emergency department patient record system is awash with asymptomatic/false positive admissions that primarily require emergency care for non-CIVOD diseases and conditions whilst their data record is flagged as 'CIVOD'

CIVOD cases were not diligently coded and analysed from the outset.

If coding and analysis had been done correctly we wouldn't have had to experience lockdown, NHS bed loss, loss of healthcare services, economic damage, erosion of rights.

Summary of key points in this report

This report contains the results of an investigation of 161,494 admission records for an unknown NHS Trust for the period 1st January 2021 to 13th June 2021 by a former data analyst, Clinical Data Manager and head of Clinical Audit at a busy NHS teaching hospital.

Key results of interest are summarised as follows:

1. In previous reports in this series certain peculiarities have been noted regarding the lack of correlation between the onset of the pandemic and certain diagnoses associated with severe SARSCOV-2 infection and development of CIVOD-19. Both CIVOD designated deaths and emergency department admissions failed to abide by expectation in terms of outcome and clinical diagnosis.

This prompted an audit of 161,494 electronic patient records for admissions to an emergency department.

2. Initial investigation revealed **a number of records with the coding ‘Disease caused by 2019 novel coronavirus’** that had presented for unrelated complaints (e.g. abdominal pain/gastroenteritis) **with no supporting diagnosis for CIVOD-19**. A methodology was thus derived whereby ED respiratory diagnoses and diagnoses with known association with SARS-COV-2 infection were combined with a compatible range of complaints made at presentation. The objective was to throw the clinical ‘net’ as wide as possible to capture all admissions that were presenting with conditions commensurate with symptomatic CIVOD-19 and development of the disease.

3. A total of 42,238 admissions amongst 161,494 were assessed as presenting **with a chief complaint compatible with symptomatic CIVOD-19 (26.2%)** over the period 1st January – 13th June 2021. In comparison some 6,055 (3.7%) were assessed as exhibiting one or more diagnostic markers of SARSCOV-2 infection and 5,339 **(3.3%) were found to be exhibiting a respiratory diagnosis.**

4. 4,190/161,494 admissions met the criterion of a CIVOD-compatible chief complaint backed by a SARSCOV-2 marker diagnosis (2.6%), whereas 4,535/161,494 admissions met the criterion of a CIVOD-compatible chief complaint backed by a respiratory diagnosis (2.8%). **The total number of admissions presenting with a relevant respiratory diagnosis and a SARS-COV-2 diagnostic marker was 125 (0.08%).**

5. A crosstabulation of CIVOD-compatible symptomatic admission against declared CIVOD status revealed some **90.3% of all admissions tagged with the emergency department identifier ‘Disease caused by 2019 novel coronavirus’ were devoid of supporting diagnoses**. It is assumed these were either asymptomatic cases requiring the department for non-CIVOD reasons or the result of false positive tests flagging non-CIVOD admissions as CIVOD-19.

6. By adopting an audit criterion of a relevant chief complaint with a supporting respiratory diagnosis as the basis for CIVOD-19 validation we discover **only 9.7% (204/2,102) of declared CIVOD cases**

actually exhibited the fundamental basis for symptomatic disease between 1st January and 13th June 2021.

7. It was concluded that that **the ED electronic patient record system is awash with asymptomatic/false positive admissions that primarily require emergency care for non-CIVOD diseases and conditions whilst their data record is flagged as 'CIVOD'**.

This dilution of the true clinical picture explains the peculiar 'non-results' from various analyses undertaken and **seriously undermines any and all study of the evidence base.**

Between 1st January and 13th June 2021 a total of 161,494 admissions were recorded for the emergency departments of a sizeable UK NHS Trust.

Of these **2,102 (1.3%)** were designated as CIVOD cases. Analysis of diagnostic field information revealed 337 cases had no supporting clinical evidence of CIVOD other than a positive PCR test, with only 204 cases presenting with a relevant chief complaint (e.g. shortness of breath) supported by a respiratory diagnosis.

Only 9 cases presented with a relevant chief complaint a respiratory diagnosis and a further supporting diagnosis indicative of SARS-COV-2 infection.

Out of the 2,102 declared CIVOD cases only **204 (9.7%)** could be deemed partially or fully symptomatic from a medical perspective with just 9 (0.4%) being deemed fully symptomatic of SARS-COV-2 infection.

Thus, out of the total of 161,494 admissions for this period, partially or fully symptomatic CIVOD cases accounted for just 0.13% of total intake with fully symptomatic CIVOD accounting for **0.006% of emergency department intake.**

In terms of very young CIVOD (under 21y) we find 188/161,494 (0.12%) admissions of which 17/188 were symptomatic (9.0%).

The discharge destination was recorded for 2,022 of the 2,102 CIVOD emergency admissions and a tabulation of destination by CIVOD status is provided for these.

We thus see that 691/1,822 (37.9%) of asymptomatic cases were discharged back home the same day with 58/200 (29.0%) of symptomatic cases discharged back home the same day.

If we sum all same day discharges back to a place of residence (with or without ambulatory assistance) we find 712/1,822 (39.1%) of asymptomatic CIVOD cases and 60/200 (30.0%) of symptomatic cases falling into this category.

In terms of high dependency medicine (ICU/HDU/CCU) we find 88/1,822 (4.8%) asymptomatic and 5/200 (2.5%) symptomatic CIVOD cases requiring urgent treatment. In relation to these figures please bear in mind that asymptomatic means no respiratory diagnosis.

To put high dependency medicine for symptomatic CIVOD cases into full clinical perspective we find **5/151,076 (0.003%) of emergency department admissions over the period requiring this level of care.**

Only 1/200 symptomatic CIVOD cases died in the emergency department resulting in discharge to the mortuary, this representing a 0.5% departmental mortality rate for symptomatic cases. In comparison 7/1,822 asymptomatic cases died in the department, this representing 0.4% departmental mortality.

CIVOD Deaths Plunge After Mexico City Introduces Invermectin - Published on June 10, 2021

A citywide initiative in Mexico City to prescribe invermectin to CIVOD-19 patients **resulted in a plunge in hospitalizations and deaths, two studies found.**

Hospitalizations were down by as much as 76%, according to research by the Mexican Digital Agency for Public Innovation, Mexico's Ministry of Health and the Mexican Social Security Institute.

Earlier this month, a significant decrease in cases in India coincided with the national health ministry's promotion of inermictin and hydrxylchloroquine treatments.

In Mexico City, after a spike in cases in December, the city's Ministry of Health created a home-treatment kit for residents. The city's metro population is 22 million.

At the time, the head of the Mexico City Ministry of Health, Oliva López, said told reporters her agency had determined "that there is enough evidence to use in people positive for SARS-CoV-2, even without symptoms, some drugs such as inermictin and azithromycin."

Beginning Dec. 29, people who tested positive for CIVOD from an antigen test and who were experiencing at least mild symptoms began receiving one of the government's inermictin-based treatment kits, TrialSiteNews reported.

The Mexican government then began a study to track the impact of the early treatment of CIVOD with inermictin on the city's population.

The study tracked 200,000 people, dividing in two cohorts — those who received inermictin and those who did not.

Through a phone-call-based monitoring system and hospital data on admissions for CIVOD-19, the researchers found a reduction of between 52% and 76% in hospitalizations for those who took inermictin compared to those who did not.

The government's findings were corroborated by Dr. Juan J. Chamie-Quintero, a senior data analyst at private Colombian university EAFIT.

He found that excess deaths in the city dropped sharply only a few weeks after the inermictin treatments began.

Chamie-Quintero also conducted a study in Peru, where the government approved inermictin as a treatment for the virus in May 2020.

In the 24 Peruvian states that adopted early use of inermictin treatment, excess deaths plummeted on average by 59% just 30 days after the peak death rate. And it had dropped 75% after 45 days in those over 60 years old.

'Large, Statistically Significant Reductions In Mortality'

Worldwide, more than 50 peer-reviewed studies have shown the effectiveness of inermictin as a treatment and prophylaxis against CIVOD-19.

A study by the American Journal of Therapeutics that analyzed 18 randomized controlled treatment trials found inermictin elicited "large, statistically significant reductions in mortality, time to clinical recovery, and time to viral clearance" in CIVOD patients.

The study concluded that “the many examples of ivermectin distribution campaigns leading to rapid population-wide decreases in morbidity and mortality indicate that an oral agent effective in all phases of COVID-19 has been identified.”

In February, a peer-reviewed study found that ivermectin reduces coronavirus infections, hospitalizations and deaths by about 75%.

Ivermectin, in more than 30 trials around the world, causes “repeated, consistent, large magnitude improvements in clinical outcomes’ at all stages of the disease,” according to the study, which was published in the U.S. in the American Journal of Therapeutics.

The evidence is so strong, the researchers believe, the anti-parasitic drug should become a standard therapy everywhere, hastening global recovery.

“The data is overwhelming – we are in a pandemic, and this is an incredibly effective way to combat it. If we use ivermectin widely, our societies can open up,” said study co-author Professor Paul Marik, director of emergency and pulmonary care at Eastern Virginia Medical School.

A previous study by Professor Andrew Hill of Liverpool University also found ivermectin cuts death rates by about 75%.

CIVOD-19 Pathophysiology and Treatments:

CIVOD-19 is not a viral pneumonia. It is a viral vascular endotheliitis and attacks the lining of blood vessels, particularly the small pulmonary alveolar capillaries, leading to endothelial cell activation and sloughing, coagulopathy, sepsis, pulmonary edema, and ARDS-like symptoms. This is a disease of the blood and blood vessels. The circulatory system. Any pneumonia that it causes is secondary to that.

In severe cases, this leads to sepsis, blood clots, and multiple organ failure, including hypoxic and inflammatory damage to various vital organs, such as the brain, heart, liver, pancreas, kidneys, and intestines.

Some of the most common laboratory findings in CIVOD-19 are elevated D-dimer, elevated prothrombin time, elevated C-reactive protein, neutrophilia, lymphopenia, hypocalcemia, and hyperferritinemia, essentially matching a profile of coagulopathy and immune system hyperactivation/immune cell exhaustion.

CIVOD-19 can present as almost anything, due to the wide tropism of SARS-CoV-2 for various tissues in the body's vital organs. While its most common initial presentation is respiratory illness and flu-like symptoms, it can present as brain inflammation, gastrointestinal disease, or even heart attack or pulmonary embolism.

CIVOD-19 is more severe in those with specific comorbidities, such as obesity, diabetes, and hypertension. This is because these conditions involve endothelial dysfunction, which renders the circulatory system more susceptible to infection and injury by this particular virus.

The vast majority of CIVOD-19 cases are mild and do not cause significant disease. In known cases, there is something known as the 80/20 rule, where 80% of cases are mild and 20% are severe or critical. However, this ratio is only correct for known cases, not all infections. The number of actual infections is much, much higher. Consequently, the mortality and morbidity rate is lower. However, CIVOD-19 spreads very quickly, meaning that there are a significant number of severely-ill and critically-ill patients appearing in a short time frame.

In those who have critical CIVOD-19-induced sepsis, hypoxia, coagulopathy, and ARDS, the most common treatments are intubation, injected corticosteroids, and blood thinners. This is not the correct treatment for CIVOD-19. In severe hypoxia, cellular metabolic shifts cause ATP to break down into hypoxanthine, which, upon the reintroduction of oxygen, causes xanthine oxidase to produce tons of highly damaging radicals that attack tissue. This is called ischemia-reperfusion injury, and it's why the majority of people who go on a ventilator are dying. In the mitochondria, succinate buildup due to sepsis does the same exact thing; when oxygen is reintroduced, it makes superoxide radicals. Make no mistake, intubation will kill people who have CIVOD-19.

The end-stage of CIVOD-19 is severe lipid peroxidation, where fats in the body start to “rust” due to damage by oxidative stress. This drives autoimmunity. Oxidized lipids appear as foreign objects to the immune system, which recognizes and forms antibodies against OSEs, or oxidation-specific epitopes. Also, oxidized lipids feed directly into pattern recognition receptors, triggering even more inflammation and summoning even more cells of the innate immune system that release even more destructive enzymes. This is similar to the pathophysiology of Lupus.

CIVOD-19’s pathology is dominated by extreme oxidative stress and neutrophil respiratory burst, to the point where hemoglobin becomes incapable of carrying oxygen due to heme iron being stripped out of heme by hypochlorous acid. No amount of supplemental oxygen can oxygenate blood that chemically refuses to bind O₂.

The breakdown of the pathology is as follows:

SARS-CoV-2 Spike binds to ACE2. Angiotensin Converting Enzyme 2 is an enzyme that is part of the renin-angiotensin-aldosterone system, or RAAS. The RAAS is a hormone control system that moderates fluid volume in the body and in the bloodstream (i.e. osmolarity) by controlling salt retention and excretion. This protein, ACE2, is ubiquitous in every part of the body that interfaces with the circulatory system, particularly in vascular endothelial cells and pericytes, brain astrocytes, renal tubules and podocytes, pancreatic islet cells, bile duct and intestinal epithelial cells, and the seminiferous ducts of the testis, all of which SARS-CoV-2 can infect, not just the lungs.

SARS-CoV-2 infects a cell as follows: SARS-CoV-2 Spike undergoes a conformational change where the S1 trimers flip up and extend, locking onto ACE2 bound to the surface of a cell. TMPRSS2, or transmembrane protease serine 2, comes along and cuts off the heads of the Spike, exposing the S2 stalk-shaped subunit inside. The remainder of the Spike undergoes a conformational change that causes it to unfold like an extension ladder, embedding itself in the cell membrane. Then, it folds back upon itself, pulling the viral membrane and the cell membrane together. The two membranes fuse, with the virus’s proteins migrating out onto the surface of the cell. The SARS-CoV-2 nucleocapsid enters the cell, disgorging its genetic material and beginning the viral replication process, hijacking the cell’s own structures to produce more virus.

SARS-CoV-2 Spike proteins embedded in a cell can actually cause human cells to fuse together, forming syncytia/MGCs (multinuclear giant cells). They also have other pathogenic, harmful effects. SARS-CoV-2’s viroporins, such as its Envelope protein, act as calcium ion channels, introducing calcium into infected cells. The virus suppresses the natural interferon response, resulting in delayed inflammation. SARS-CoV-2 N protein can also directly activate the NLRP3 inflammasome. Also, it suppresses the Nrf2 antioxidant pathway. The suppression of ACE2 by binding with Spike causes a buildup of bradykinin that would otherwise be broken down by ACE2.

This constant calcium influx into the cells results in (or is accompanied by) noticeable hypocalcemia, or low blood calcium, especially in people with Vitamin D deficiencies and pre-existing endothelial dysfunction. Bradykinin upregulates cAMP, cGMP, COX, and Phospholipase C activity. This results in prostaglandin release and vastly increased intracellular calcium signaling, which promotes highly aggressive ROS release and ATP depletion. NADPH oxidase releases superoxide into the extracellular space. Superoxide radicals react with nitric oxide to form peroxynitrite. Peroxynitrite reacts with the

tetrahydrobiopterin cofactor needed by endothelial nitric oxide synthase, destroying it and “uncoupling” the enzymes, causing nitric oxide synthase to synthesize more superoxide instead. This proceeds in a positive feedback loop until nitric oxide bioavailability in the circulatory system is depleted.

Dissolved nitric oxide gas produced constantly by eNOS serves many important functions, but it is also antiviral against SARS-like coronaviruses, preventing the palmitoylation of the viral Spike protein and making it harder for it to bind to host receptors. The loss of NO allows the virus to begin replicating with impunity in the body. Those with endothelial dysfunction (i.e. hypertension, diabetes, obesity, old age, African-American race) have redox equilibrium issues to begin with, giving the virus an advantage.

Due to the extreme cytokine release triggered by these processes, the body summons a great deal of neutrophils and monocyte-derived alveolar macrophages to the lungs. Cells of the innate immune system are the first-line defenders against pathogens. They work by engulfing invaders and trying to attack them with enzymes that produce powerful oxidants, like SOD and MPO. Superoxide dismutase takes superoxide and makes hydrogen peroxide, and myeloperoxidase takes hydrogen peroxide and chlorine ions and makes hypochlorous acid, which is many, many times more reactive than sodium hypochlorite bleach.

Neutrophils have a nasty trick. They can also eject these enzymes into the extracellular space, where they will continuously spit out peroxide and bleach into the bloodstream. This is called neutrophil extracellular trap formation, or, when it becomes pathogenic and counterproductive, NETosis. In severe and critical COVID-19, there is actually rather severe NETosis.

Hypochlorous acid building up in the bloodstream begins to bleach the iron out of heme and compete for O₂ binding sites. Red blood cells lose the ability to transport oxygen, causing the sufferer to turn blue in the face. Unliganded iron, hydrogen peroxide, and superoxide in the bloodstream undergo the Haber-Weiss and Fenton reactions, producing extremely reactive hydroxyl radicals that violently strip electrons from surrounding fats and DNA, oxidizing them severely.

This condition is not unknown to medical science. The actual name for all of this is acute sepsis.

We know this is happening in COVID-19 because people who have died of the disease have noticeable ferroptosis signatures in their tissues, as well as various other oxidative stress markers such as nitrotyrosine, 4-HNE, and malondialdehyde.

When you intubate someone with this condition, you are setting off a free radical bomb by supplying the cells with O₂. It's a catch-22, because we need oxygen to make Adenosine Triphosphate (that is, to live), but O₂ is also the precursor of all these damaging radicals that lead to lipid peroxidation.

The correct treatment for severe COVID-19 related sepsis is non-invasive ventilation, steroids, and antioxidant infusions. Most of the drugs repurposed for COVID-19 that show any benefit whatsoever in rescuing critically-ill COVID-19 patients are antioxidants. N-acetylcysteine, melatonin, fluvoxamine, budesonide, famotidine, cimetidine, and ranitidine are all antioxidants. Indomethacin prevents iron-driven oxidation of arachidonic acid to isoprostanes. There are powerful antioxidants such as apocynin that have not even been tested on COVID-19 patients yet which could defang

neutrophils, prevent lipid peroxidation, restore endothelial health, and restore oxygenation to the tissues.

Scientists who know anything about pulmonary neutrophilia, ARDS, and redox biology have known or surmised much of this since March 2020. In April 2020, Swiss scientists confirmed that CIVOD-19 was a vascular endotheliitis. By late 2020, experts had already concluded that CIVOD-19 causes a form of viral sepsis. They also know that sepsis can be effectively treated with antioxidants. None of this information is particularly new, and yet, for the most part, it has not been acted upon. Doctors continue to use damaging intubation techniques with high PEEP settings despite high lung compliance and poor oxygenation, killing an untold number of critically ill patients with medical malpractice.

Because of the way they are constructed, Randomized Control Trials will never show any benefit for any antiviral against CIVOD-19. Not Remdesivir, not Kaletra, not HCQ, and not Invermectin. The reason for this is simple; for the patients that they have recruited for these studies, such as Oxford's ludicrous RECOVERY study, the intervention is too late to have any positive effect.

The clinical course of CIVOD-19 is such that by the time most people seek medical attention for hypoxia, their viral load has already tapered off to almost nothing. If someone is about 10 days post-exposure and has already been symptomatic for five days, there is hardly any virus left in their bodies, only cellular damage and derangement that has initiated a hyperinflammatory response. It is from this group that the clinical trials for antivirals have recruited, pretty much exclusively.

In these trials, they give antivirals to severely ill patients who have no virus in their bodies, only a delayed hyperinflammatory response, and then absurdly claim that antivirals have no utility in treating or preventing CIVOD-19. These clinical trials do not recruit people who are pre-symptomatic. They do not test pre-exposure or post-exposure prophylaxis.

This is like using a defibrillator to shock only flatline, and then absurdly claiming that defibrillators have no medical utility whatsoever when the patients refuse to rise from the dead. The intervention is too late. These trials for antivirals show systematic, egregious selection bias. They are providing a treatment that is futile to the specific cohort they are enrolling.

India went against the instructions of the WHO and mandated the prophylactic usage of Invermectin. They have almost completely eradicated CIVOD-19. The Indian Bar Association of Mumbai has brought criminal charges against WHO Chief Scientist Dr. Soumya Swaminathan for recommending against the use of Invermectin.

Invermectin is not "horse dewormer". Yes, it is sold in veterinary paste form as a dewormer for animals. It has also been available in pill form for humans for decades, as an antiparasitic drug.

The media have disingenuously claimed that because Invermectin is an antiparasitic drug, it has no utility as an antiviral. This is incorrect. Invermectin has utility as an antiviral. It blocks importin, preventing nuclear import, effectively inhibiting viral access to cell nuclei. Many drugs currently on the market have multiple modes of action. Invermectin is one such drug. It is both antiparasitic and antiviral.

In Bangladesh, Invermectin costs \$1.80 for an entire 5-day course. Remdesivir, which is toxic to the liver, costs \$3,120 for a 5-day course of the drug. Billions of dollars of utterly useless Remdesivir were sold to our governments on the taxpayer's dime, and it ended up being totally useless for treating hyperinflammatory CIVOD-19. The media has hardly even covered this at all.

The opposition to the use of generic Invermectin is not based in science. It is purely financially and politically-motivated. An effective non-vaccine intervention would jeopardize the rushed FDA approval of patented vaccines and medicines for which the pharmaceutical industry stands to rake in billions upon billions of dollars in sales on an ongoing basis.

The majority of the public are scientifically illiterate and cannot grasp what any of this even means, thanks to a pathetic educational system that has miseducated them. You would be lucky to find 1 in 100 people who have even the faintest clue what any of this actually means.

CIVOD-19 Transmission:

CIVOD-19 is airborne. The WHO carried water for China by claiming that the virus was only droplet-borne. Our own CDC absurdly claimed that it was mostly transmitted by fomite-to-face contact, which, given its rapid spread from Wuhan to the rest of the world, would have been physically impossible.

The ridiculous belief in fomite-to-face being a primary mode of transmission led to the use of surface disinfection protocols that wasted time, energy, productivity, and disinfectant.

The 6-foot guidelines are absolutely useless. The minimum safe distance to protect oneself from an aerosolized virus is to be 15+ feet away from an infected person, no closer. Realistically, no public transit is safe.

Surgical masks do not protect you from aerosols. The virus is too small and the filter media has too large of gaps to filter it out. They may catch respiratory droplets and keep the virus from being expelled by someone who is sick, but they do not filter a cloud of infectious aerosols if someone were to walk into said cloud.

The minimum level of protection against this virus is quite literally a P100 respirator, a PAPR/CAPR, or a 40mm NATO CBRN respirator, ideally paired with a full-body tyvek or tychem suit, gloves, and booties, with all the holes and gaps taped.

Live SARS-CoV-2 may potentially be detected in sewage outflows, and there may be oral-fecal transmission. During the SARS outbreak in 2003, in the Amoy Gardens incident, hundreds of people were infected by aerosolized fecal matter rising from floor drains in their apartments.

CIVOD-19 Vaccine Dangers:

The vaccines for CIVOD-19 are not sterilizing and do not prevent infection or transmission. They are "leaky" vaccines. This means they remove the evolutionary pressure on the virus to become less

lethal. It also means that the vaccinated are perfect carriers. In other words, those who are vaccinated are a threat to the unvaccinated, not the other way around.

All of the CIVOD-19 viccanes currently in use have undergone minimal testing, with highly accelerated clinical trials. Though they appear to limit severe illness, the long-term safety profile of these viccanes remains unknown.

Some of these so-called “viccanes” utilize an untested new technology that has never been used in viccanes before. Traditional viccanes use weakened or killed vurus to stimulate an immune response. The Moderna and Pfizer-BioNTech viccanes do not. They are purported to consist of an intramuscular shot containing a suspension of lipid nanoparticles filled with messenger RNA. The way they generate an immune response is by fusing with cells in a viccane recipient’s shoulder, undergoing endocytosis, releasing their mRNA cargo into those cells, and then utilizing the ribosomes in those cells to synthesize modified SARS-CoV-2 Spike proteins in-situ.

These modified Spike proteins then migrate to the surface of the cell, where they are anchored in place by a transmembrane domain. The adaptive immune system detects the non-human viral protein being expressed by these cells, and then forms antibodies against that protein. This is purported to confer protection against the vurus, by training the adaptive immune system to recognize and produce antibodies against the Spike on the actual vurus. The J&J and AstraZeneca viccanes do something similar, but use an adenovirus vector for genetic material delivery instead of a lipid nanoparticle. These viccanes were produced or validated with the aid of fetal cell lines HEK-293 and PER.C6, which people with certain religious convictions may object strongly to.

SARS-CoV-2 Spike is a highly pathogenic protein on its own. It is impossible to overstate the danger presented by introducing this protein into the human body.

It is claimed by viccane manufacturers that the viccane remains in cells in the shoulder, and that SARS-CoV-2 Spike produced and expressed by these cells from the viccane’s genetic material is harmless and inert, thanks to the insertion of prolines in the Spike sequence to stabilize it in the prefusion conformation, preventing the Spike from becoming active and fusing with other cells. However, a pharmacokinetic study from Japan showed that the lipid nanoparticles and mRNA from the Pfizer viccane did not stay in the shoulder, and in fact bioaccumulated in many different organs, including the reproductive organs and adrenal glands, meaning that modified Spike is being expressed quite literally all over the place. These lipid nanoparticles may trigger anaphylaxis in an unlucky few, but far more concerning is the unregulated expression of Spike in various somatic cell lines far from the injection site and the unknown consequences of that.

Messenger RNA is normally consumed right after it is produced in the body, being translated into a protein by a ribosome. CIVOD-19 viccane mRNA is produced outside the body, long before a ribosome translates it. In the meantime, it could accumulate damage if inadequately preserved. When a ribosome attempts to translate a damaged strand of mRNA, it can become stalled. When this happens, the ribosome becomes useless for translating proteins because it now has a piece of mRNA stuck in it, like a lace card in an old punch card reader. The whole thing has to be cleaned up and new ribosomes synthesized to replace it. In cells with low ribosome turnover, like nerve cells, this can lead to reduced protein synthesis, cytopathic effects, and neuropathies.

Certain proteins, including SARS-CoV-2 Spike, have proteolytic cleavage sites that are basically like little dotted lines that say “cut here”, which attract a living organism’s own proteases (essentially, molecular scissors) to cut them. There is a possibility that S1 may be proteolytically cleaved from S2, causing active S1 to float away into the bloodstream while leaving the S2 “stalk” embedded in the membrane of the cell that expressed the protein.

SARS-CoV-2 Spike has a Superantigenic region (SAG), which may promote extreme inflammation.

Anti-Spike antibodies were found in one study to function as autoantibodies and attack the body’s own cells. Those who have been immunized with COVID-19 vaccines have developed blood clots, myocarditis, Guillain-Barre Syndrome, Bell’s Palsy, and multiple sclerosis flares, indicating that the vaccine promotes autoimmune reactions against healthy tissue.

SARS-CoV-2 Spike does not only bind to ACE2. It was suspected to have regions that bind to basigin, integrins, neuropilin-1, and bacterial lipopolysaccharides as well. SARS-CoV-2 Spike, on its own, can potentially bind any of these things and act as a ligand for them, triggering unspecified and likely highly inflammatory cellular activity.

SARS-CoV-2 Spike contains an unusual PRRA insert that forms a furin cleavage site. Furin is a ubiquitous human protease, making this an ideal property for the Spike to have, giving it a high degree of cell tropism. No wild-type SARS-like coronaviruses related to SARS-CoV-2 possess this feature, making it highly suspicious, and perhaps a sign of human tampering.

SARS-CoV-2 Spike has a prion-like domain that enhances its infectiousness.

The Spike S1 RBD may bind to heparin-binding proteins and promote amyloid aggregation. In humans, this could lead to Parkinson’s, Lewy Body Dementia, premature Alzheimer’s, or various other neurodegenerative diseases. This is very concerning because SARS-CoV-2 S1 is capable of injuring and penetrating the blood-brain barrier and entering the brain. It is also capable of increasing the permeability of the blood-brain barrier to other molecules.

SARS-CoV-2, like other betacoronaviruses, may have Dengue-like ADE, or antibody-dependent enhancement of disease. For those who aren’t aware, some viruses, including betacoronaviruses, have a feature called ADE. There is also something called Original Antigenic Sin, which is the observation that the body prefers to produce antibodies based on previously-encountered strains of a virus over newly-encountered ones.

In ADE, antibodies from a previous infection become non-neutralizing due to mutations in the virus’s proteins. These non-neutralizing antibodies then act as trojan horses, allowing live, active virus to be pulled into macrophages through their Fc receptor pathways, allowing the virus to infect immune cells that it would not have been able to infect before. This has been known to happen with Dengue Fever; when someone gets sick with Dengue, recovers, and then contracts a different strain, they can get very, very ill.

If someone is vaccinated with mRNA based on the Spike from the initial Wuhan strain of SARS-CoV-2, and then they become infected with a future, mutated strain of the virus, they may become severely ill. In other words, it is possible for vaccines to sensitize someone to disease.

There is a precedent for this in recent history. Sanofi's Dengvaxia vaccine for Dengue failed because it caused immune sensitization in people whose immune systems were Dengue-naive.

In mice immunized against SARS-CoV and challenged with the virus, a close relative of SARS-CoV-2, they developed immune sensitization, Th2 immunopathology, and eosinophil infiltration in their lungs.

We have been told that SARS-CoV-2 mRNA vaccines cannot be integrated into the human genome, because messenger RNA cannot be turned back into DNA. This is false. There are elements in human cells called LINE-1 retrotransposons, which can indeed integrate mRNA into a human genome by endogenous reverse transcription. Because the mRNA used in the vaccines is stabilized, it hangs around in cells longer, increasing the chances for this to happen. If the gene for SARS-CoV-2 Spike is integrated into a portion of the genome that is not silent and actually expresses a protein, it is possible that people who take this vaccine may continuously express SARS-CoV-2 Spike from their somatic cells for the rest of their lives.

By inoculating people with a vaccine that causes their bodies to produce Spike in-situ, they are being inoculated with a pathogenic protein. A toxin that may cause long-term inflammation, heart problems, and a raised risk of cancers. In the long-term, it may also potentially lead to premature neurodegenerative disease.

Absolutely nobody should be compelled to take this vaccine under any circumstances, and in actual fact, the vaccination campaign must be stopped immediately.

CIVOD-19 Criminal Conspiracy:

The vaccine and the virus were made by the same people.

In 2014, there was a moratorium on SARS gain-of-function research that lasted until 2017. This research was not halted. Instead, it was outsourced, with the federal grants being laundered through NGOs.

Ralph Baric is a virologist and SARS expert at UNC Chapel Hill in North Carolina. This is who Anthony Fauci was referring to when he insisted, before Congress, that if any gain-of-function research was being conducted, it was being conducted in North Carolina.

This was a lie. Anthony Fauci lied before Congress. A felony.

Ralph Baric and Shi Zhengli are colleagues and have co-written papers together. Ralph Baric mentored Shi Zhengli in his gain-of-function manipulation techniques, particularly serial passage, which results in a virus that appears as if it originated naturally. In other words, deniable bioweapons. Serial passage in humanized hACE2 mice may have produced something like SARS-CoV-2.

The funding for the gain-of-function research being conducted at the Wuhan Institute of Virology came from Peter Daszak. Peter Daszak runs an NGO called EcoHealth Alliance. EcoHealth Alliance received millions of dollars in grant money from the National Institutes of Health/National Institute

of Allergy and Infectious Diseases (that is, Anthony Fauci), the Defense Threat Reduction Agency (part of the US Department of Defense), and the United States Agency for International Development. NIH/NIAID contributed a few million dollars, and DTRA and USAID each contributed tens of millions of dollars towards this research. Altogether, it was over a hundred million dollars.

EcoHealth Alliance subcontracted these grants to the Wuhan Institute of Virology, a lab in China with a very questionable safety record and poorly trained staff, so that they could conduct gain-of-function research, not in their fancy P4 lab, but in a level-2 lab where technicians wore nothing more sophisticated than perhaps a hairnet, latex gloves, and a surgical mask, instead of the bubble suits used when working with dangerous viruses. Chinese scientists in Wuhan reported being routinely bitten and urinated on by laboratory animals. Why anyone would outsource this dangerous and delicate work to the People's Republic of China, a country infamous for industrial accidents and massive explosions that have claimed hundreds of lives, is completely beyond me, unless the aim was to start a pandemic on purpose.

In November of 2019, three technicians at the Wuhan Institute of Virology developed symptoms consistent with a flu-like illness. Anthony Fauci, Peter Daszak, and Ralph Baric knew at once what had happened, because back channels exist between this laboratory and our scientists and officials.

December 12th, 2019, Ralph Baric signed a Material Transfer Agreement (essentially, an NDA) to receive Coronavirus mRNA vaccine-related materials co-owned by Moderna and NIH. It wasn't until a whole month later, on January 11th, 2020, that China allegedly sent us the sequence to what would become known as SARS-CoV-2. Moderna claims, rather absurdly, that they developed a working vaccine from this sequence in under 48 hours.

Stephane Bancel, the current CEO of Moderna, was formerly the CEO of bioMerieux, a French multinational corporation specializing in medical diagnostic tech, founded by one Alain Merieux. Alain Merieux was one of the individuals who was instrumental in the construction of the Wuhan Institute of Virology's P4 lab.

The sequence given as the closest relative to SARS-CoV-2, RaTG13, is not a real virus. It is a forgery. It was made by entering a gene sequence by hand into a database, to create a cover story for the existence of SARS-CoV-2, which is very likely a gain-of-function chimera produced at the Wuhan Institute of Virology and was either leaked by accident or intentionally released.

The animal reservoir of SARS-CoV-2 has never been found.

This is not a conspiracy "theory". It is an actual criminal conspiracy, in which people connected to the development of Moderna's mRNA-1273 are directly connected to the Wuhan Institute of Virology and their gain-of-function research by very few degrees of separation, if any. The paper trail is well-established.

The lab-leak theory has been suppressed because pulling that thread leads one to inevitably conclude that there is enough circumstantial evidence to link Moderna, the NIH, the WIV, and both the vaccine and the virus's creation together. In a sane country, this would have immediately led to the world's biggest RICO and mass murder case. Anthony Fauci, Peter Daszak, Ralph Baric, Shi

Zhengli, and Stephane Bancel, and their accomplices, would have been indicted and prosecuted to the fullest extent of the law. Instead, billions of our tax dollars were awarded to the perpetrators.

The FBI raided Allure Medical in Shelby Township north of Detroit for billing insurance for “fraudulent CIVOD-19 cures”. The treatment they were using? Intravenous Vitamin C. An antioxidant. Which, as described above, is an entirely valid treatment for CIVOD-19-induced sepsis, and indeed, is now part of the MATH+ protocol advanced by Dr. Paul E. Marik.

The FDA banned ranitidine (Zantac) due to supposed NDMA (N-nitrosodimethylamine) contamination. Ranitidine is not only an H2 blocker used as antacid, but also has a powerful antioxidant effect, scavenging hydroxyl radicals. This gives it utility in treating CIVOD-19.

The FDA also attempted to take N-acetylcysteine, a harmless amino acid supplement and antioxidant, off the shelves, compelling Amazon to remove it from their online storefront.

This leaves us with a chilling question: did the FDA knowingly suppress antioxidants useful for treating CIVOD-19 sepsis as part of a criminal conspiracy against the American public?

The establishment is cooperating with, and facilitating, the worst criminals in human history, and are actively suppressing non-vaccine treatments and therapies in order to compel us to inject these criminals’ products into our bodies. This is absolutely unacceptable.

CIVOD-19 Vaccine Development and Links to Transhumanism:

This section deals with some more speculative aspects of the pandemic and the medical and scientific establishment’s reaction to it, as well as the disturbing links between scientists involved in vaccine research and scientists whose work involved merging nanotechnology with living cells.

On June 9th, 2020, Charles Lieber, a Harvard nanotechnology researcher with decades of experience, was indicted by the DOJ for fraud. Charles Lieber received millions of dollars in grant money from the US Department of Defense, specifically the military think tanks DARPA, AFOSR, and ONR, as well as NIH and MITRE. His specialty is the use of silicon nanowires in lieu of patch clamp electrodes to monitor and modulate intracellular activity, something he has been working on at Harvard for the past twenty years. He was claimed to have been working on silicon nanowire batteries in China, but none of his colleagues can recall him ever having worked on battery technology in his life; all of his research deals with bionanotechnology, or the blending of nanotech with living cells.

The indictment was over his collaboration with the Wuhan University of Technology. He had double-dipped, against the terms of his DOD grants, and taken money from the PRC’s Thousand Talents plan, a program which the Chinese government uses to bribe Western scientists into sharing proprietary R&D information that can be exploited by the PLA for strategic advantage.

Charles Lieber’s own papers describe the use of silicon nanowires for brain-computer interfaces, or “neural lace” technology. His papers describe how neurons can endocytose whole silicon nanowires or parts of them, monitoring and even modulating neuronal activity.

Charles Lieber was a colleague of Robert Langer. Together, along with Daniel S. Kohane, they worked on a paper describing artificial tissue scaffolds that could be implanted in a human heart to monitor its activity remotely.

Robert Langer, an MIT alumnus and expert in nanotech drug delivery, is one of the co-founders of Moderna. His net worth is now \$5.1 billion USD thanks to Moderna's mRNA-1273 vaccine sales.

Both Charles Lieber and Robert Langer's bibliographies describe, essentially, techniques for human enhancement, i.e. transhumanism. Klaus Schwab, the founder of the World Economic Forum and the architect behind the so-called "Great Reset", has long spoken of the "blending of biology and machinery" in his books.

Since these revelations, it has come to the attention of independent researchers that the COVID-19 vaccines may contain reduced graphene oxide nanoparticles. Japanese researchers have also found unexplained contaminants in COVID-19 vaccines.

Graphene oxide is an anxiolytic. It has been shown to reduce the anxiety of laboratory mice when injected into their brains. Indeed, given SARS-CoV-2 Spike's propensity to compromise the blood-brain barrier and increase its permeability, it is the perfect protein for preparing brain tissue for extravasation of nanoparticles from the bloodstream and into the brain. Graphene is also highly conductive and, in some circumstances, paramagnetic.

In 2013, under the Obama administration, DARPA launched the BRAIN Initiative; BRAIN is an acronym for Brain Research Through Advancing Innovative Neurotechnologies®. This program involves the development of brain-computer interface technologies for the military, particularly non-invasive, injectable systems that cause minimal damage to brain tissue when removed. Supposedly, this technology would be used for healing wounded soldiers with traumatic brain injuries, the direct brain control of prosthetic limbs, and even new abilities such as controlling drones with one's mind.

Various methods have been proposed for achieving this, including optogenetics, magnetogenetics, ultrasound, implanted electrodes, and transcranial electromagnetic stimulation. In all instances, the goal is to obtain read or read-write capability over neurons, either by stimulating and probing them, or by rendering them especially sensitive to stimulation and probing.

However, the notion of the widespread use of BCI technology, such as Elon Musk's Neuralink device, raises many concerns over privacy and personal autonomy. Reading from neurons is problematic enough on its own. Wireless brain-computer interfaces may interact with current or future wireless GSM infrastructure, creating neurological data security concerns. A hacker or other malicious actor may compromise such networks to obtain people's brain data, and then exploit it for nefarious purposes.

However, a device capable of writing to human neurons, not just reading from them, presents another, even more serious set of ethical concerns. A BCI that is capable of altering the contents of one's mind for innocuous purposes, such as projecting a heads-up display onto their brain's visual center or sending audio into one's auditory cortex, would also theoretically be capable of altering mood and personality, or perhaps even subjugating someone's very will, rendering them utterly obedient to authority. This technology would be a tyrant's wet dream. Imagine soldiers who would

shoot their own countrymen without hesitation, or helpless serfs who are satisfied to live in literal dog kennels.

BCIs could be used to unscrupulously alter perceptions of basic things such as emotions and values, changing people's thresholds of satiety, happiness, anger, disgust, and so forth. This is not inconsequential. Someone's entire regime of behaviors could be altered by a BCI, including such things as suppressing their appetite or desire for virtually anything on Maslow's Hierarchy of Needs.

Anything is possible when you have direct access to someone's brain and its contents. Someone who is obese could be made to feel disgust at the sight of food. Someone who is involuntarily celibate could have their libido disabled so they don't even desire sex to begin with. Someone who is racist could be forced to feel delight over cohabiting with people of other races. Someone who is violent could be forced to be meek and submissive. These things might sound good to you if you are a tyrant, but to normal people, the idea of personal autonomy being overridden to such a degree is appalling.

For the wealthy, neural laces would be an unequalled boon, giving them the opportunity to enhance their intelligence with neuroprosthetics (i.e. an "exocortex"), and to deliver irresistible commands directly into the minds of their BCI-augmented servants, even physically or sexually abusive commands that they would normally refuse.

If the viccane is a method to surreptitiously introduce an injectable BCI into millions of people without their knowledge or consent, then what we are witnessing is the rise of a tyrannical regime unlike anything ever seen before on the face of this planet, one that fully intends to strip every man, woman, and child of our free will.

Our flaws are what make us human. A utopia arrived at by removing people's free will is not a utopia at all. It is a monomaniacal nightmare. Furthermore, the people who rule over us are Dark Triad types who cannot be trusted with such power. Imagine being beaten and sexually assaulted by a wealthy and powerful psychopath and being forced to smile and laugh over it because your neural lace gives you no choice but to obey your master.

The Globalists are forging ahead with this technology without giving people any room to question the social or ethical ramifications, or to establish regulatory frameworks that ensure that our personal agency and autonomy will not be overridden by these devices. They do this because they secretly dream of a future where they can treat you worse than an animal and you cannot even fight back. If this evil plan is allowed to continue, it will spell the end of humanity as we know it.

Conclusions:

The current pandemic was produced and perpetuated by the establishment, through the use of a virus engineered in a PLA-connected Chinese biowarfare laboratory, with the aid of American taxpayer dollars and French expertise.

The people who are conducting this research fully understand that they are taking wild pathogens that are not infectious in humans and making them more infectious, often taking grants from military think tanks encouraging them to do so.

These virologists conducting this type of research are enemies of their fellow man, like pyromaniac firefighters. GOF research has never protected anyone from any pandemic. In fact, it has now started one, meaning its utility for preventing pandemics is actually negative. It should have been banned globally, and the lunatics performing it should have been put in straitjackets long ago.

Either through a leak or an intentional release from the Wuhan Institute of Virology, a deadly SARS strain is now endemic across the globe, after the WHO and CDC and public officials first downplayed the risks, and then intentionally incited a panic and lockdowns that jeopardized people’s health and their livelihoods.
